#### **Investment Objective**

The fund's objective is to generate long-term capital gains by investing primarily in quality American small and mid-cap companies that have a sustainable competitive advantage. Companies with a market capitalisation of less than \$30 billion are considered for investment. The fund aims to generate higher risk-adjusted returns than its benchmark universe over a full market cycle.

A minimum of 30% of the fund's assets will be invested in sustainable assets.


The fund manager implements an active strategy based on solid convictions.





What a wild month it has been for the stock market. Market moves in early April were extreme before bouncing off the lows and then mounting a sustained rally through to the end of the month. It is hard to believe we would reclaim much, if not all, of the post "liberation day" losses so quickly.

Equity markets experienced a turbulent April, as the US announced a tariff policy that was much more severe than had been expected before this was gradually walked back to less extreme levels incrementally through the rest of the month. President Trump also made negative comments about Fed Chair Powell which served to further un-nerve markets, but again subsequently retracted much of what he had said.

In this environment the BL American Small & Mid Caps Fund once more managed to better resist on the down side compared to its official Benchmark, the MSCI US Small + Mid Cap NR USD Index.

There were no outright sales or purchases of holdings made in the month. Nevertheless, some smaller adjustments were made to the portfolio right after the "liberation day". On one side we slightly decreased our holdings in Littelfuse, Zebra Technologies and Masimo (potential biggest tariff impact) and on the other side increased our holdings in Bentley Systems, Rollins, CDW and ULTA.

The top 5 contributors in the month were Verisign, Bentley Systems, Resmed, Core & Main and Equifax. The top 5 detractors were BIO-Techne, Watsco, LKQ, Zebra and Pool.
